

**CITY OF DONCASTER COUNCIL
(VARIOUS ROADS DONCASTER)
SPEED LIMITS (CONSOLIDATION) ORDER 2011
(AMENDMENT NO.) ORDER 2025**

Notice is hereby given that the City of Doncaster Council propose to make an Order under the provisions of the Road Traffic Regulation Act 1984 and all other enabling powers.

The effect of the order will be to:

- (i) Remove the existing 20mph speed limit on the following roads:

School Lane, Auckley which extends from its junction with main street in a generally northerly direction to a point 5 metres southeast of its junction with Spey Drive, Auckley

- (ii) introduce a 20 mph speed limit on the following roads

BELL BUTTS LANE from its junction with Main Street for a distance of 65 metres in a generally southwesterly direction

COMMON LANE from its junction with Main Street for a distance of 440 metres in a generally northeasterly direction
